Q&A

What inspired you to apply for the Eric H. Holder, Jr. Fellowship?

I have long wanted to have a legal career where I could make a social justice impact. It went from being a personal aspiration to an imperative after the 2016 presidential election. LDF in particular has such a storied history as the premier civil rights law firm in the country, so it was an obvious choice. I wanted to be here to continue that legacy of racial justice work and combat the civil rights incursions of the new Administration.

What are you most looking forward to about your work as an Eric H. Holder, Jr. Fellow?

LDF threw me right into the deep end of the pool within weeks. I traveled to Alabama to do election protection work, and I loved it. I'm eager to build on LDF's achievements in criminal justice and voting rights. Frankly, I'm excited to tackle racial justice issues from all angles.
